25/053 DECLARATIONS OF INTEREST, DISCLOSABLE PECUNIARY INTERESTS, AND DISPENSATIONS

25/053.1 New Written Requests for Dispensations

There were no new requests.

25/053.2 Declarations of Interest

Members were invited to declare any Disclosable Pecuniary or other Interest in any item of business on the agenda and, if necessary, leave the meeting prior to discussion of that item. Councillor Dutton declared an interest in planning application 25/02104/PIP as she knew the immediate neighbour. No other declarations were made.

25/054 OPEN FORUM

25/054.1 Three residents had informed the meeting that they were in the process of applying for planning permission to install a freestanding black metal handrail running from St Andrews Church gate down the slope to the footpath. They had highlighted some of the issues involved including ownership of the land and being in the conservation area. They had been advised to make contact with the conservation officer who would be able to explain what was possible.

25/054.2 Comment had been expressed regarding minute 25/037.2 of the previous meeting by the resident who had reported the issue to Cheshire West and Chester Council. The footpath had been reported as obstructed (vegetation overgrowth), and also that a section of the wall was leaning towards the footpath adjacent to a large tree and was at risk of collapse. The vegetation had been removed from the footpath and wall and the area generally tidied up. This had exposed the dressed stonework on top of the wall. This stonework was not in an unsafe state and was believed to have been removed due to theft by parties unknown. However, the area of the wall that was leaning into the footway adjacent to the tree (that was included in the original report to Cheshire West and Chester

Council) was not addressed, and it remained as leaning towards the footpath in an unsafe manner.

25/054.3 Potential Issues from New Housing in Kelsall

25/055 MINUTES OF THE MEETING HELD ON 23RD JUNE 2025.

RESOLVED: that the minutes of the meeting held on 23rd June 2025 be signed by the Chairman of the meeting as a correct record.

25/056 REPORTS ON MATTERS ARISING FROM THE MINUTES OF THE MEETING HELD ON 23RD JUNE 2025 NOT COVERED BY THE AGENDA

25/056.1 Wall Lower High Street (Previous Minute 25/037.2)

The piece of wall that had been removed was the piece reported to the landowner by Council as unsafe.

RESOLVED: that the Clerk make contact with Highways and the Landowner to seek clarification on what each party had done.

25/056.2 Speed Monitoring (Previous Minute 25/037.1)

The meeting noted that all four of the residents who had indicated that they would help with speed monitoring had provided their contact details and they had been given to the PCSO covering the Parish who had in turn responded.

RESOLVED: that the Clerk invite the PCSO to the next meeting to discuss his response to the Clerk regarding future use of smart SID's.

25/056.3 Correspondence from resident re Asbestos (Previous Minute 25/048.4) The landowner had said that the warning signs displayed on the building were there to deter the individuals who had been breaking into the property on multiple occasions and causing damage to the structure of the building. There were traces of asbestos in the wall structure which if undisturbed are not a risk to passing members of the public. The resident had been informed accordingly but had been disappointed with the explanation. In a further letter to the Clerk, she had indicated that living so close to the buildings in question she would have expected the landowner to have ensured safe removal of the asbestos. She had also forwarded some general information on asbestos from the government which she thought would be of use to Council in the future.

25/056.4 Grants to Local Organisations (Previous Minute 25/045)

The meeting noted that all organisations who had received a grant had acknowledged receipt with thanks, and some had also sent letters of appreciation.

25/056.5 Defibrillator outside Community Centre (Previous Minute 25/046)

The meeting noted that the defibrillator had been put back on the National Network but there were still issues with the person who should be carrying out the checks.

RESOLVED: that the Clerk raise this matter at a future meeting when due to the confidential nature of the business the public and press may need to be temporarily excluded.

25/057 PLANNING MATTERS

25/057.1 Planning Applications

RESOLVED: that the following comments be made on the planning applications submitted:

25/01808/FUL – Loft conversion to create one bedroom – 27 Bye-Pass Road, Tarvin

Comment: No objection

25/01632/FUL - Erection of garden building at rear of garden (resubmission of 22/01392/FUL – Sunnyside, Church Street, Tarvin

Comment: We have no objection in principle but have a concern about the overall height and question the intended use of the building bearing in mind its extensive facilities. Should the application be approved the garden building should remain interdependent with the main house and any occupancy of the building should be restricted to relatives or short-term visitors visiting the occupant of Sunnyside.

25/02104/PIP – Erection of 9 dwellings and associated infrastructure works – Land at Bye Pass Road, Tarvin

Comment: We object to this application as it is contrary to Policy HG2 of the Tarvin Neighbourhood Plan, is on farmland designated Green Belt, is outside the village envelope, and to access village facilities a main road has to be crossed.

25/057.3 PLANNING DIFFICULTIES IN CHESHIRE VILLAGES

25/057.3.1 Meeting with the Head of Planning.

The meeting was unable to progress this due to the absence of Cheshire West and Chester Councillor Cooper.

25/057.3.2 Consideration of employing a contractor to develop a Settlement Spatial Plan.

RESOLVED: that the Council look to employ a contractor to develop a plan and that the Clerk obtain a quote for the work.

25/057.4 Appeal

The erection of a building (shed) in front of the principal elevation. (the unauthorised development) – 58 Hockenhull Avenue, Tarvin.

At the December 2024 Council meeting it had been reported that Cheshire West and Chester Council had spoken to the landowner and tenant about the building and advised the need for planning permission. No application had been received, so an enforcement notice had been served to remove the building. The enforcement notice had been appealed, and the Borough Council had been in the process of submitting statements and other relevant documentation.

The appeal had now been heard and dismissed.

25/057.5 25/01850/OUT - Outline planning application for the erection of up to 60 residential dwellings (including affordable housing), introduction of structural planting and landscaping, public open space, sustainable urban drainage system and associated works (all matters reserved except for access) – Land Off Church Street, Tarvin The above application had been validated by Cheshire West and Chester Council **RESOLVED**: that the application be considered at the next Council meeting.

25/058 KING GEORGE V PLAYING FIELD

25/058.1 Molibus and Matting

The replacement parts were expected in August, the delay being due to them coming from Poland.

25/058.2 Surfaces

The preferred quote from the wet pour provider amounted to £5,588.50 plus VAT and a different contractor had quoted £2,350.00 to carry out the work on site.

RESOLVED: that the above be approved.

25/059 STREETLIGHTING COLUMNS

The Streetcare working party agreed with the resident that the five streetlighting columns on Lower High Street needed painting, but Council considered the work low priority.

25/060 THREE YEAR TREE SURVEY

RESOLVED: that no further action was necessary

25/061 COMMUNITY LED MINOR HIGHWAY IMPROVEMENTS

Highways were looking to undertake a trial initiative focused on small-scale maintenance works on the Highway network that local communities and Parish/Town Councils considered valuable for enhancing their areas.

The trial would involve one of their contractor's maintenance crews, consisting of two operatives and vehicle, equipped to carry out minor tasks that did not require additional materials such as tarmac. Councils were asked to draw up a list of minor improvements and forward it to Highways for consideration.

RESOLVED: that the attached list be forwarded to Highways for consideration.

25/066.3 United Utilities water main on Kelsall Road

The meeting noted that United Utilities were aiming to replace the water main on Kelsall Road with the works scheduled for August 2025.

"I can only apologise this was missed at the time of submission.

I have looked at your request alongside recorded data we have for this location. There have been two recorded injury incidents within the last five years up to 13th August 2024. To qualify for funding for improvement as part of our small Local Safety Scheme (LSS) programme, we look at locations with four or more recorded injury collisions over four years. The location would therefore not meet criteria for an LSS.

With regards to requests for new speed limits or reductions, we're currently reviewing our speed limit policy, so new requests are currently on hold. I will put this location on file so your request can be reviewed once the new policy has been introduced."
