25/071 DECLARATIONS OF INTEREST, DISCLOSABLE PECUNIARY INTERESTS, AND DISPENSATIONS

25/071.1 New Written Requests for Dispensations

There were no new requests.

25/071.2 Declarations of Interest

Members were invited to declare any Disclosable Pecuniary or other Interest in any item of business on the agenda and, if necessary, leave the meeting prior to discussion of that item. No such declarations were made.

25/072 OPEN FORUM

25/072.1 Most of the residents had been in attendance to either comment on or listen to comments on Planning Application 25/01850/OUT. Both positive and negative views had been put forward. Considerable concern had been expressed regarding the current pipe network that dealt with foul and surface water as it could not cope with the existing properties. During heavy rainfall conditions gardens at the lower area of Hockenhull Avenue and Tarporley Road became flooded with foul water/sewage. Other concerns raised included the ability of the school and doctor surgery to cope with higher numbers, potential increase in traffic around the school, siting of the car parks not being beneficial to the wider community, position of bus stops, preservation of trees, retaining the public footpaths adjacent to the site, loss of green space, and lack of a facility for children with bikes. There was support for the scheme and in particular the provision of a much needed full-size football pitch, the extra houses/residents should benefit local businesses, the school should benefit as it was under capacity, and that if properties have to be built in Tarvin that was the ideal place.

The Chairman had encouraged everyone to ensure their views were logged on the Cheshire West and Chester Planning website during the coming few days.

25/072.2 Speed Monitoring (Previous Minute 25/056.2)

One of the residents who had volunteered to help with speed monitoring had reported on an e-mail from PCSO Hannath. The e-mail had indicated that:

25/072.2.1 Pool Lane was not suitable for any road safety or community speed watch as there was no parking or pavement to operate safely.

25/072.2.2 the Police had previously trained three residents for Lower High Street, but they had been unhappy with the assessment and never carried out any work

25/072.2.3 the Police had no funding to supply a speed monitor, uniform etc.

The resident had asked for clarification on the way forward.

25/073 MINUTES OF THE MEETING HELD ON 28TH JULY 2025.

25/074 REPORTS ON MATTERS ARISING FROM THE MINUTES OF THE MEETING HELD ON 28TH JULY 2025 NOT COVERED BY THE AGENDA

25/074.1 Potential Issues from New Housing in Kelsall (Previous Minute 25/054.3) The meeting noted that the Clerk had forwarded a copy of the presentation to Kelsall Parish Council, and several Kelsall Councillors had met with the residents who had provided the report.

25/074.2 "Don't let your hedge be a hazard" leaflets. (Previous Minute 25/066.5) The meeting noted that the Clerk had a supply of leaflets. Councillors were encouraged to take some with them at the end of the meeting.

25/074.3 Speed Monitoring (Previous Minute 25/056.2)

PCSO Hannath had sent his apologies for non-attendance. He had informed the Clerk that smart SIDs were portable, battery powered speed indicator signs and tripod. They displayed the speed but also recorded the date, time, speed as data. The cost was approximately £3,500. He thought that three very local Councils had purchased them and that they were using them and moving them around rather than sticking to one location. **RESOLVED (25/074.3.1):** that the Clerk arranged a meeting with PCSO Hannath and

RESOLVED (25/074.3.2): that Council cover the costs of any resident undergoing training to use SIDs.

25/075.1 Planning Applications

RESOLVED: that the following comments be made on the planning applications submitted:

25/01850/OUT - Outline planning application for the erection of up to 60 residential dwellings (including affordable housing), introduction of structural planting and landscaping, public open space, sustainable urban drainage system and associated works (all matters reserved except for access) – Land Off Church Street, Tarvin

Comment: We have no objection but are extremely concerned about the ongoing problem with surface water and foul drainage which has built up over many years and fundamentally needs to be addressed. Residents have separately raised valid and evidenced concerns regarding these existing problems and we fully support those concerns.

Regarding the affordable properties we wish to see the Discounted Market Sale Scheme used as eligibility is determined with regard to local incomes and local house prices, and frequently households with a local connection to the area are given priority.

Should the application be approved, we would like to see the following conditions:

- It is crucial that ALL the community benefits specified in this application are delivered as specified.
- o In designing the layout of the houses, consideration MUST be given to ensuring views from Church Street/Tarporley Road towards Kelsall Hill are preserved as far as practicable. There also needs to be recognition that the site is close to the Tarvin Conservation Area
- o Internal roads, street lighting and drainage must be constructed to an adoptable standard.

25/02080/S73 - Extensions to front and rear, link to garage conversion into habitable use, alterations to elevations to include window and door openings. - variation of condition 2 (approved plans) and condition 3 (materials) of planning application 24/03250/FUL – Meadowside, Weetwood

RESOLVED (25/075.4.2): that the Community Infrastructure Levy fund be used to cover the expenditure.

25/076 DEFINITIVE MAP MODIFICATION

Order relating to Tarvin CWAC/004 (Church Street and Cross Lanes)

Cheshire West and Chester Council were recommending refusal for the proposed addition of a footpath on land between Church Street and Cross Lanes. The independent consultant believed that the various legal tests were not met which were essential in order to prove the path was a Public Right of Way. The meeting noted one factual error on the consultant's report. It said that the Parish Council had been consulted, but that was not the case.

RESOLVED: that Councillor Lush call the report in for further consideration.
